

Caring Globally, Researching Locally: Resources on International Humanitarian Law

With war raging in Ukraine and Gaza and tensions between the U.S. and Venezuela playing out in air strikes in the Caribbean Sea, questions about the scope of international humanitarian law are unavoidable. Meanwhile, the world's military lawyers grapple with how these issues raised by these wars factor into joint operations and other collective actions.

In the U.S., these conflicts are barely covered by the press anymore, which is absorbed in domestic events. Churches, college student groups and peace organizations look on in dismay as international institutions appear to be incapable of effective action to protect civilian populations caught up in these wars.

As lawyers, we tend to listen to these issues being discussed with a skeptical ear unless we hear someone join an actual international law to a persuasive argument. After all, most of us have lived through wars with catastrophic claims of imminent use of "weapons of mass destruction" or that our adversary is part of an "axis of evil," rhetoric later found to be untrue or exaggerated. This article is going to leave aside these claims

and show you where to find the law.

Resources

International Committee of the Red Cross

International Committee of the Red Cross (ICRC) has been at the forefront of promoting and implementing humanitarian law since its founders organized the Geneva Convention of 1863 which adopted the first articles defining standards of lawful warfare and crimes of war. Because of its unique history, its website hosts a vital repository of legal materials, the International Humanitarian Law Databases (https://ihl-databases.icrc.org/en). This site is organized under three headers: Treaties, Customary Law and National Practice.

The core collection of Treaties includes the currently operative 1949 Geneva Convention and the 1977 and 2005 Protocols, but there are also collections of related international agreements and historical treaties (https://ihl-databases.icrc.org/en/ihl-treaties/geneva-conventions-1949additional-protocols-and-their-commentaries).

The Customary IHL tab (https://ihl-databases.icrc.org/en/customary-ihl) is deceptively useful—especially its Rules tab, which is effectively an authoritative encyclopedia of humanitarian law, organized by topic with references to all the treaty materials related to the subject. For example, if you look at Rule 76, Herbicides, you see that while the use of these chemicals in warfare is not expressly prohibited, their use may violate certain UN resolutions, which are cited, and may come under other provisions, like prohibition on attacking objects indispensable to the survival of the civilian population, which is referenced.


The Practice tab of the Customary IHL page is also very useful as it allows you to search by the name of a nation to find UN resolutions specifically referencing that country, as well as official statements they make to formally declare that a particular treaty provision cannot apply to them under their national law.

The Sources tab directs you to the text of all relevant treaties and references statements of national laws found in military manuals, national laws and national case law. Humanitarian law is not just an ideal, it is integrated into the core documents of military law and the rules of engagement for most of the nations of the world. This is not just a matter of ethical principle, it is also self-interest. The world's generals don't want their captive soldiers mistreated nor do they want their forces involved in banned acts of warfare. Full-text versions of this original source material are also collected under the National Practices tab of the main Customary IHL page, and it is searchable by nation, type of practice or material and date. (The documents are not always in English.)

International Court of Justice (ICJ)

Another important place to look for information on humanitarian law is on the websites of the two bodies that administer international law, the International Court of Justice which resolves legal conflicts between nation-states, and the International Criminal Court (ICC), which prosecutes individuals when that court

has jurisdiction (because not all nation states are party to the ICC).

The ICJ, or the World Court (https://www. icj-cij.org/), adjudicates cases between nations over a variety of matters as diverse as disputes over borders, conflicts over civil aviation rules, the movement of migrants and, at least recently, a claim by a state that another state has violated the Convention on the Prevention and Punishment of the Crime of Genocide. This area of ICJ law, which is still developing, comes out of a 2019 action by The Gambia (joined now by 11 other nations) against Myanmar over the treatment of the Rohingya people. The Genocide Convention allows any state to enforce its provisions, and as Myanmar is not a signatory to the Statute of the International Criminal Court, the ICJ ruled that the Court was the only competent body to judge the claim. More controversially, as the Myanmar case has slowly proceeded, South Africa filed a claim against Israel for its actions in the Gaza conflict. Decisions in the preliminary stages of these matters can be found on the front page and under the decisions tab. Since ICJ litigation usually takes years if not decades to resolve, this will be an active area of humanitarian law for the foreseeable future.

International Criminal Court (ICC)

While the ICJ tries cases between nations, the ICC hears cases involving individuals charged with crimes against humanity. Its jurisdiction is limited to crimes by signatories to the 1998 Rome Statute of the International Criminal Court or that occur on the territory of a signatory. The Court's interpretation of its jurisdiction has been controversial, especially since it allowed the indictment of Benjamin Netanyahu, the prime minister of a non-signatory, for actions related to Israel's prosecution of its war in Gaza, which, as part of the Palestinian Authority, is a signatory. (The U.S. has recently sanctioned ICC officials over this ruling.)

The Rome Statute and its amendments can be found under Documents on the Core Legal Texts tab (https://www.icc-cpi.int/publications/core-legal-texts), along with rules of court and professional ethics. Decisions and Records of the ICC are found in the Court Records folder (https://www.icc-cpi.int/decisions). The ICC News tab is useful in following hearings, new rulings and other matters.

Other Resources

The Resources web page of the American Society of International Law (ASIL) (https://www.asil.org/resources) has several beneficial resources, including news articles, podcasts and videos. Of particular interest, is found under Topics, Human Rights and International Criminal Law (https://www.asil.org/topics/humanrights-and-international-criminal-law). You can search by keyword, perhaps "Ukraine," and add Tags like either "Signature Topics: Atrocity Prevention" or "Use of Force, International Humanitar-

ian Law" to pull up a number of on-point articles and other posts.

LBA Human Rights Section

Researching is one thing, doing as another. Members of the Louisville Bar Association interested in this area of law should join the Human Right Section to get active in this area. In its own words, it "seeks to educate the Bench and Bar on timely topics that are also the basis of new law and policy forming around them to keep up with the everincreasing pace of the global village in which we find ourselves working and living to a greater degree every day." The section often features speakers with expertise in human rights law, domestic and global, with recent programs in human trafficking, civil rights and immigration law. From the Office of the Circuit Court Clerk

Following an ordinance passed by the Louisville Metro Council recently, court costs and filing fees in Jefferson County have been increased.

This Court Facilities Fee took effect on Nov. 1, 2025. It will help fund an estimated \$40 million in deferred maintenance and repairs to the Jefferson Countyowned Hall of Justice, Judicial Center and the Old Jail Building for projects such as:

- Escalator and elevator repairs
- · Roofing/leak repairs
- · Plumbing and security upgrades
- · Ongoing building maintenance


It should be noted that 101 other Kentucky counties currently collect a Court Facilities Fee as passed by local ordinance, which the state legislature authorizes by statute.

The Court Facilities Fee is now automatically applied to court costs and civil filing fees when either eFiled or conventionally filed. The new charges, which range from \$10 to \$25, apply to both circuit and district court cases.

Specific fee increases:

- Circuit Civil cases: The filing fee increased by \$25.
 This also includes a \$25 additional filing fee for appeals to the Court of Appeals.
- Circuit Criminal cases: Court costs increased by \$25.
- District Civil cases: The filing fee increased by \$10.
- District Criminal cases: Court costs increased by \$10 for traffic and by \$20 for misdemeanor cases.

Lead. Serve. Excel: The Return of the LBA Leadership Academy

The LBA has reinstated its Leadership Academy, a structured professional development initiative originally launched in 2006. After a multi-year hiatus, the program returns with a renewed focus on preparing mid-career attorneys for leadership roles in law, business and civic life.

The Academy is designed for attorneys with four to ten years of practice. This career stage is critical: practitioners have accumulated substantive experience but are still defining their long-term trajectory. The program addresses this transitional phase by offering targeted instruction in leadership competencies and facilitating strategic professional connections.

Curriculum Structure

The Academy's curriculum is segmented into modules that build essential leadership skills. Topics include:

- · Strategic planning and team building
- · Ethics and professionalism in leadership
- · Business development strategies
- · Community engagement and social responsibility
- Technology and innovation in legal practice
- · Change management and diversity integration

Each session is designed to be practical, incorporating case studies, interactive exercises and direct engagement with community leaders. The program emphasizes applied learning over theoretical instruction.

New Partnership with Leadership Louisville

This year, the Academy introduces a partnership with Leadership Louisville, integrating a session from its "Leading Better" program. This collaboration expands the Academy's scope by exposing participants to leadership methodologies validated across multiple sectors.

Addressing a Professional Development Gap

The Academy's absence created a noticeable void in regional legal training. Demand for its return reflects a broader recognition that leadership development must be intentional and structured. Informal mentorship and passive learning are insufficient for preparing attorneys to assume leadership roles.

The need is underscored by demographic trends. According to the American Bar Association's 2023 Profile of the Legal Profession, more than half of practicing attorneys in the United States are over the age of 50. Succession planning is no longer optional. Firms, nonprofits and civic institutions require a pipeline of attorneys equipped to lead.

Impact of Remote Work on Mentorship

The COVID-19 pandemic accelerated remote work adoption, which, while operationally effective, diminished opportunities for informal mentorship. A Harvard Business Review study found that remote employees are 25 percent less likely to

receive informal mentoring. In a profession that relies heavily on apprenticeship models, this reduction in spontaneous professional exchange has long-term implications. The Academy's in-person format is a deliberate response to this challenge.

Leadership and Business Development

Leadership development is directly correlated with business outcomes. Thomson Reuters' 2022 Law Firm Business Leaders Report found that firms investing in leadership training report stronger client relationships and improved associate retention. The Academy equips participants with skills that enhance internal team dynamics and external client engagement.

Graduates gain competencies in communication, team integration and strategic networking. These skills contribute to firm performance and position attorneys for civic leadership roles, including nonprofit board service and bar association committee participation.

Networking and Relationship Building

The Academy's in-person structure is intentional. Face-to-face interaction fosters trust and accelerates relationship development. According to the Conference Board's 2024 Leadership Development Survey, 73 percent of executives identify relationship building as the most critical leadership competency. However, it is also the skill most weakened by virtual-only environments.

Each Academy cohort functions as a professional network. Participants often maintain these relationships beyond the program year, creating long-term channels for collaboration and referral.

Alumni Outcomes

Since its inception, the Academy has inducted more than 100 attorneys. Alumni have advanced into roles including judicial appointments, firm partnerships and leadership positions within the LBA. These outcomes validate the program's structure and its emphasis on practical leadership development.

Program Philosophy

The Academy operates under a clear directive: Lead. Serve. Excel. Its objective is not to produce leaders for title's sake but to cultivate attorneys who lead with ethical clarity, professional rigor and civic responsibility.

Leadership in law requires credibility. Every decision, whether in client representation or board service, reflects on the profession's integrity. The Academy reinforces this principle, framing leadership as stewardship rather than status.

Service is integral to the Academy's mission. Participants are challenged to apply their skills in service to the broader community. Louisville benefits when legal professionals engage in nonprofit leadership, volunteer initiatives and policy advocacy. The Academy positions civic engagement as a professional obligation.

Excellence is treated as a continuous process. The program instills habits of self-assessment and ongoing improvement, encouraging attorneys to refine their skills throughout their careers.

Strategic Value

Participation in the Academy offers measurable professional advantages. Structured leadership training accelerates readiness for partnership, firm management and judicial service. Cohort membership provides access to a peer network that supports collaboration and business development.

Leadership skills enhance client confidence and retention. The program also opens pathways to civic visibility through board service and community engagement. The partnership with Leadership Louisville introduces cross-sector leadership strategies, broadening participants' perspective.

The Academy is not a symbolic credential. It is a tactical investment with immediate and long-term returns. Graduates leave with enhanced capabilities, expanded networks and increased credibility.

The reinstatement of the LBA Leadership Academy is a strategic recommitment to the values that sustain the legal profession: integrity, service and excellence. For attorneys in the four-to-ten-year practice window, the program offers a structured path to leadership readiness.

The Academy prepares participants not only to serve clients but to lead firms, nonprofits and civic institutions. Its return signals a renewed focus on equipping the next generation of attorneys for the responsibilities ahead.

Lead. Serve. Excel. The standard remains unchanged. The opportunity to meet it has returned.

This Veterans Day, we celebrate those who served by helping them overcome barriers to long-term stability. Legal Aid Society's Veterans Legal Assistance Program provides critical support - housing, benefits, and other civil legal help - to those who've defended our country.

Since January, we've served 142 veterans, but the need remains great: in 2021, **76% of low-income veteran households faced at least one civil legal problem, and nearly half experienced five or more.**

Legal Aid - A lifeline for Veterans like Matt.

When Matt Gibbins joined the Navy at 22 years old, he had never left Allentown, PA. While his yearlong service on the USS Nimitz allowed him to see the world, it also left him with lifelong injuries. As an aircraft mechanic, he spent most of 1986 and '87 on the flight deck of the Nimitz surrounded by deafening equipment. Nearly 40 years later, Matt describes the tinnitus as "constant"—yet the VA denied that Matt's hearing loss was related to his working environment. Unfortunately, stories like this are all too common in the Veteran community, as supplemental claims, higher-level reviews, and appeals are often required for any approval of benefits. This administrative burden and delay in benefits left Matt in significant economic hardship. With a litany of worsening injuries, both service-related and not, Matt became homeless and contemplated suicide. Mere moments before carrying out the act, Matt called his Legal Aid Attorney, Roy Berwick. Thanks to Matt's brave call to Legal Aid in his greatest moment of need, he is alive today and feels confident knowing someone is fighting for him. "Roy is my poster child," he said, describing Veteran's Unit Senior Attorney Roy Berwick. "I've seen how Veterans are treated. I wouldn't be trying anymore—not without him."

Unlocking the Power of Cellphone Records in Kentucky Civil Litigation

Practical strategies for obtaining, interpreting and admitting digital evidence under the Stored Communications Act in Kentucky

At a Glance

Cellphone records are becoming indispensable in civil litigation, from motor vehicle and wrongful death actions to employment and family law disputes. Understanding the Stored Communications Act and Kentucky discovery rules is essential to obtaining usable evidence. This article outlines the types of data available, the legal hurdles to obtaining them and practical strategies for Kentucky litigators.

Why Cellphone Records Matter in Civil Cases

Cellphone records are no longer confined to police investigations. In Kentucky civil courts, they increasingly play a decisive role. From proving or disproving distracted driving in auto cases to clarifying timelines in family or contract disputes, digital breadcrumbs can be powerful.

But getting and using these records is not straightforward. The federal Stored Communications Act (SCA) sets strict limits, and Kentucky's discovery rules provide only certain tools for civil practitioners.

What's Out There — And Why It Matters

Cellphone evidence generally falls into several categories:

- · Call Detail Records (CDRs): Logs of calls and texts, showing time, number and duration, but not content.
- Cell Site Location Information (CSLI): Which tower and sector handled a call or data session; useful for estimating location.
- Timing Advance (TA): Where available, an estimate of the phone's distance
- App and Cloud Data: Google Timeline, Apple "Significant Locations," WhatsApp logs or social media account data; often requires consent or direct login credentials.

Retention periods vary, so issuing preservation letters early is essential.

The Legal Hurdles — and How to Clear Them

The Stored Communications Act prohibits carriers from releasing subscriber records without consent—even with a subpoena. Kentucky courts, like others, follow this federal limitation.

Kentucky practitioners can use:

- Subscriber Consent: the most direct route, using carrier-provided forms.
- Court-Compelled Consent: courts may order a party to sign consent forms under CR 34 or CR 37.
- Third-Party Discovery: if a non-carrier (such as an employer) controls the records, CR 34 or CR 45 subpoenas may apply.
- Preservation Requests: while Kentucky does not allow pre-litigation subpoenas, counsel should move quickly to secure preservation orders once litigation is reasonably anticipated.

Privacy and Kentucky Case Law

The U.S. Supreme Court in Carpenter v. United States recognized a reasonable expectation of privacy in historical CSLI, requiring warrants for law enforcement access. The Kentucky Supreme Court followed this in Commonwealth v. Reed, applying Carpenter to state prosecutions and confirming CSLI is protected information. Civil courts are likely to adopt the same privacy-protective approach — allowing discovery but limiting scope to ensure relevance and proportionality.

Case Spotlight: Motorcycle Crash and Driver Deception

In a Kentucky civil case, plaintiff's counsel represented a motorcyclist permanently injured when struck by a truck making an illegal turn. The truck driver stated that at the time of the crash, he had just returned to duty after taking the previous 24 hours off. According to the driver, while he was resting, another employee used his truck to make and receive deliveries.

Plaintiff's counsel sought to test this account by moving for a court order compelling production of the driver's cellphone records. The driver provided written consent, and the court also issued an order authorizing release of the data. Subsequent analysis of those records revealed that the driver's story was false. The data showed that he had, in fact, been with his truck, making deliveries and picking up products across Kentucky in the 24 hours before the accident. This not only undercut his credibility but also demonstrated a violation of federal and state commercial driver regulations governing rest periods.

The analysis exposed deception and provided leverage for settlement. The case illustrates how cellphone records can be decisive in civil litigation. both for proving or disproving statements and for establishing liability beyond the immediate accident itself.



CMS Takes Control of Medicaid with the Rural Health Transformation Program

When it was signed into law on July 4, 2025, the One Big Beautiful Bill Act (OBBBA) significantly reduced Medicaid funding nationwide by \$911 billion over a period of 10 years. Medicaid expansion states, i.e., those that expanded Medicaid under the Affordable Care Act like Kentucky, will bear the brunt, seeing more than 13 percent reduction in funding over the next decade. See https://www.kff.org/medicaid/allocating-cbos-estimates-of-federal-medicaid-spending-reductions-and-enrollment-loss-across-the-states/.

OBBBA Reduces Medicaid Funding

Medicaid is funded through a complex system of federal funds and state funds received from provider taxes and state-directed payments. Historically, states managed their own Medicaid programs with guidance and oversight from the federal government. Kentucky's state-directed payment program is the Hospital Rate Improvement Program (HRIP) which "makes it possible for hospitals to draw down more federal funds so that Medicaid reimbursements will be closer to the average commercial rate rather than the Medicare rate of reimbursement. The funds are fied to quality metrics hospitals must meet in order to receive the improved reimbursement." See https://www. khaquality.com/programs/hrip-quality-program/. According to the Kentucky Hospital Association, these funds keep rural hospitals open while also improving patient outcomes because they receive more Medicaid funding, which makes up the difference between the actual cost of care and the low Medicare rate of reimbursement. See https://kyhealthnews.net/2025/01/12/ kentuckys-hospital-rate-improvement-program-brings-moremoney-and-better-health-outcomes-to-hospitals/. Kentucky's HRIP program is funded by the provider tax on hospitals. Id.

The OBBBA removes incentives for states to expand Medicaid and prohibits new provider taxes and reduces existing provider taxes, making it significantly harder for states to fund Medicaid. Rural areas have a larger percentage of Medicaid recipients. As a result, numerous rural hospitals face closure due to the reduction in funding. According to the Sheps Center for Health Services Research at the University of North Carolina at Chapel Hill, 338 rural hospitals nationwide are at risk of closure due to the OBBBA Medicaid cuts, including 35 hospitals in Kentucky, the most closures faced by any state.

Because the OBBBA's Medicaid cuts will disproportionately affect rural health hospitals, Congress included the Rural Health Transformation Program (RHTP) in Section 71401 of the OBBBA. The United States' Senate Fact Sheet on the RHTP states that "the OBBBA does make reforms to prevent states from exploiting sources of federal Medicaid revenue" and "require[s] states to refocus their Medicaid programs on the truly vulnerable patients for which the program was intended." See U.S. Senate Committee on Finance RHTP Fact Sheet. The RHTP is intended to "serve as a bridge to shore up rural hospitals and prevent gaps in care." Id. Under the RHTP, CMS now has much greater oversight and control over the allocation of Medicaid funds while states have far less control than previously.

Overview of the RHTP

The RHTP will be administered by the Centers for Medicare and Medicaid Services (CMS). The purpose of the RHTP is "to strengthen health care across rural America... designed to empower states to transform the existing rural health care infrastructure and build sustainable health care systems that expand access, enhance quality of care, and improve outcomes for patients." See https://www.cms.gov/newsroom/press-releases/cms-launches-landmark-50-billion-rural-health-transformation-program. The RHTP has five strategic

goals: 1) Make rural America healthy again; 2) Sustainable access; 3) Workforce development; 4) Innovative care; and 5) Tech innovation. *Id.* The program is funded for five years with \$10 billion to be made available each year. *Id.* CMS "will partner with states over the program period to ensure strong oversight and successful implementation of initiatives with lasting impact." *Id.*



Lack of funding could result in hospital closures, workforce reductions and decreased access to healthcare in rural areas as well as increased demand for healthcare services in urban areas, the impacts of which will be felt statewide.

While the RHTA has allocated \$50 billion in funding, half of that funding will be spread out among the states that are approved to participate in the program. See https://www. cms.gov/priorities/rural-health-transformation-rht-program/ overview. The other half of the funding "will be allocated by CMS based on a variety of factors including rural population, the proportion of rural health facilities in the State, the situation of certain hospitals in the State, and other factors to be specified by CMS in the [Notice of Funding Opportunity]." Id. States are required to use the funds for three or more of the following approved uses: prevention and chronic disease; provider payments; consumer tech solutions; training and technical assistance; workforce; IT advances; appropriate care availability; behavioral health; and innovative care. See Rural Health Transformation Program NOFO at 11-12. Funds also may be used for capital expenditures and infrastructure and fostering collaboration between rural facilities and other health care providers. Id. at 12.

Application process for RHTP

CMS issued its Notice of Funding Opportunity on September 15, 2025. Each state must apply to the program by November 5, 2025, and CMS will announce the awardees by December 31, 2025. The Governor's office of each state is tasked with designating an agency or office to handle the application process. See Rural Health Transformation-FAQ. The application must include "a letter of endorsement from the Governor that expresses support for the proposed rural health transformation plan and certifies that the application has been developed with certain key stakeholders." Id. The U.S. Territories and Washington, D.C. are not eligible to receive an award from the RHTP. Id. A state's application will be scored by a combination of 1) rural facility and population score factors and 2) workload funding, each compromising 50% of the score. See AMA Summary: Rural Health Transformation Program at 2. A state's workload funding score is calculated based on initiative-based factors, i.e. proposed initiatives for use of RHTP funds; state policy-based factors, i.e. current state policy policies that the state commits to enacting; and datadriven metrics. Id. There are limitations on use of funds,

such as no more than 10 percent of the funds may be used on administrative expenses and funds may not be used to pay for clinical services already reimbursed by another source like insurance, Medicare, CHIP, etc. *Id.* at 3. RHTP funding is not guaranteed and "depends on the availability of funds, program authority, satisfactory performance, and compliance with the terms and conditions of the Federal award." See Rural Health Transformation Program NOFO at 60.

If a state is approved, then it receives funds all five years as long as it complies with the RHTP requirements. *Id.* No matching funds from the state are required. Once the awards are made, then monitoring will begin in 2026. *Id.* at 13. Post-Award financial and performance reports are required as well as noncompeting continuation applications. *Id.* at 59-60. There will be no other application opportunities for the RHTP.

States' Response to the RHTP

Forty-six states have requested public input in preparation for their application to the RHTP. See https://shvs.org/ $tracking\hbox{-}state\hbox{-}preparation\hbox{-}for\hbox{-}the\hbox{-}rural\hbox{-}health\hbox{-}transforma$ tion-program/. Two states have requested public input and solicited a consultant. Id. While Kentucky has not published any requests for input on its application, the Medicaid Oversight and Advisory Board met on August 27, 2025. Dr. Steven Stack, Kentucky's Secretary of CHFS, updated the committee on the application process and noted that a vendor had been chosen to support "deployment and programmatic changes." The report of the Kentucky Rural Health Transformation Program on the same date indicates that letters were issued in July to stakeholders requesting input with responses due by August 31, 2025. There also was a Kentucky Rural Health Clinic Summit in August which included a listening session on rural health transformation. The Kentucky RHTP's next steps include continued stakeholder engagement and review of feedback; monitoring CMS guidance and application release in September; and coordination with the governor's office to develop and submit Kentucky's application by the deadline.

Potential Consequences of Reduction in Medicaid Funding

Even if they are approved, states will still be short of funds after receiving their allocated funding under the RHTP. The Kaiser Family Foundation found that the RHTP funds only partially offset the reductions because rural areas will lose approximately \$137 billion in Medicaid funding as a result of the OBBBA. See https://www.kff.org/medicaid/how-might-federal-medicaid-cuts-in-the-enacted-reconciliation-package-affect-rural-areas/. It noted that "Kentucky would experience the largest rural Medicaid spending reduction, with an estimated drop of \$11 billion over 10 years." Id.

As a result of this funding shortfall, states will be faced with the difficult choice of having to come up with funds to make up the difference or reduce or eliminate some rural healthcare services. Lack of funding could result in hospital closures, workforce reductions and decreased access to healthcare in rural areas as well as increased demand for healthcare services in urban areas, the impacts of which will be felt statewide.
